
On recommendation of the Selection Committee constituted for selection of Junior Clerks by way of direct recruitment, the following successful candidates are hereby appointed temporarily as Junior Clerk in regular scale of Pay Band-2 Rs. 5,200/- to Rs.20,200/- with Grade Pay Rs.1900/- & usual D.A. and other allowances as admissible from time to time by Government from the date of their joining in the post under the following terms and conditions;

On appointment they are posted to the office as mentioned against their name:

1. The appointment is purely temporary and can be terminated at any time without assigning any reason thereof.
2. They are under probation for a period of two years and the appointing authority reserves the right to terminate the services of a probationer or extend the probation further period as considered necessary if during the probation period the work and conduct of the employee is found to be unsatisfactory or there are reasons to believe that the employee will not be suitable for the post.
3. Any document proved to be contrary or forged on verification at any time, the services of the employee concerned will be terminated without assigning any reason thereof and prosecution will be initiated against him for submission of forged document.
4. No T.E. is allowed for joining the post.
5. They are directed to join in the place of posting within 15 days from the date of receipt of this order.
6. They should submit the following documents at the time of their joining before the concerned Head of the Department.
 - i) Xerox and attested copy of H.S.C. Certificate
 - ii) Two character certificates from the Gazetted Group A or Group B Officers.
 - iii) Medical Certificate of fitness from a Medical Officer not below the rank of an Asst. Surgeon of any Govt. Hospital.
 - iv) An oath of allegiance to the constitution of India.
 - v) An affidavit to the effect that no criminal case is pending against them.
 - vi) Marital status certificate


