


**TERMS AND CONDITIONS FOR ENGAGEMENT OF VEHICLE FOR DPMSU/
BPMSU and MHU, NAYAGARH**

1. The vehicle must be a multi utility vehicle showing a mileage of at least 12 KMS per liter.
2. The vehicle should be less than 2 (Two) years old from the date of manufacturing as on dt.1.10.11.
3. The vehicles will be located at any place within Nayagarh at the discretion of the undersigned.
4. The period of contract shall be one year from the date of agreement. Extension will be given after satisfactory performance of the vehicle during the period of contract.
5. The Transporters/Tour Operators/ Travel Agents/ Private Organisations /NGO's/Individual should have situated in Nayagarh district or having its branch/Office in Nayagarh.
6. Only MAHINDRA XYLO/TATA SUMO/BOLERO/SCORPIO/TRAVERA will be considered for engagement on monthly as well as on day to day basis to be used for the purpose of DPMSU/BPMSU & MHU under NRHM, CDMO office, Nayagarh.
7. The interested party should submit their proposals in the prescribed application form in two envelopes – one for technical bid and second for financial bid and both the sealed covers should be put into a third outer cover duly super scribed as **"QUOTATION FOR ENGAGEMENT OF VEHICLE FOR_____"**. For example- one party has submitted his quotation for BPMSU than he should write on the top left corner of the sealed envelope that **"QUOTATION FOR ENGAGEMENT OF VEHICLE FOR BPMSU"**. *The bid document which is received without mentioning the "QUOTATION FOR ENGAGEMENT OF VEHICLE FOR....." on the top of the envelop containing both financial and technical bid document will be liable to be rejected.*
8. The contract of engagement shall be entered into with a travel agency/individual and MO I/c of concerned block where vehicles will be located.
9. The vehicle to be engaged should not belong to any employee or the close relative of NRHM and health and Family welfare department
10. The vehicle must be available with driver at any time for official purpose even after the office hour and holidays as desired by the district and block officials. During holidays the vehicle should not be utilized for the purpose of any private work of the owner of the vehicle. The owner of the vehicle shall also not allow the vehicle to be given on hire during holidays and unofficial hours. Deviation in this matter will be seriously viewed and vehicle will be liable to be disengaged.
11. The cost entire major and minor repair shall be borne by the owner of vehicle. The BPMSU & DPMSU will provide only fuel and lubricants.

12. The maintenance of vehicle and payment of road tax will be borne by the owner of the vehicle.
13. The remuneration of driver shall be borne by the owner.
14. The bidders shall have to furnish EMD of **Rs.5,000/- (Rupees Five Thousand only)** in the form of cross Demand Draft/Pay Order in favor of Zilla Swasthya Samiti(NRHM),Nayagarh with the application for engagement of vehicle.
15. The sealed quotations must reach to the office of the undersigned on or before **dt. 27/10/2011 up to 4.P.M** either through Speed Post /Registered Post /courier only.
16. The Bid documents which qualifies for the technical bid will be called for opening of financial bid on Dt. **27/10/2011 up to 4.P.M.**
17. The authority reserves the right to accept or reject any/all bids without assigning any reasons thereof.
18. The authority will not be responsible for any postal delay.
19. The Bid document which qualifies for the technical bid will be eligible for opening of financial bid.
20. The details of vehicles to be engaged.
